TERMS OF BOOKING - Congress Registration

- By completing this booking form, you are in agreement to the booking instructions on the registration form, Terms and Conditions, Cancellation Policy and Privacy Policy for IALP 2023
- Registrations are by the completion of the online registration form only.
- Bookings or changes will not be accepted by telephone. Cancellations and or changes must be sent in writing to the registration desk at registration@ialpauckland2023.org.
- There is no refund for non-attendance.
- A name change on a paid registration will be accepted up to two weeks before the congress.
- Payment by Invoice/Bank Transfer will incur a \$25 charge for bank charges and administration.
- All fees/rates are quoted in New Zealand Dollars \$, all bank transfer fees/charges are the responsibility of the delegate.
- No booking will be confirmed in full until payment is received in full.
- Any payments or refunds by bank transfer are subject to a \$25 administration fee.
- Participants are strongly recommended to have their own travel insurance in place (to cover medical, cancellation and all other risks associated) and are responsible for all travel arrangements including visa applications if required.
 Refunds cannot be offers outside of the terms listed above
- The congress (IALP 2023), Keynote PCO acting as booking office for IALP 2023 and the committees will not be held liable for any loss or damage of personal items of attendees or injury caused at any venue used in connection with the congress.

CANCELLATION TERMS – Congress Registration

Delegate Cancellations

- All cancellations and/or changes must be sent in writing to <u>registration@ialpauckland2023.org</u>
- Cancellation refers to complete and/or partial cancellation of registrations, social events and tours.
- Cancellation fees are incurred as follows
 Cancellations received prior to 30th April 2023 full refund less administration fee of \$85.00
 Between 1st May 2023 and 20th May 2023 50% refund less administration fee of \$85.00
 After 21st May 2023 No refund for cancelled registrations

Delegate Non-Attendance



• Should the delegate be unable to attend due to circumstances beyond their control, cancellation fees are subject to terms listed above. This includes the delegate being unable to travel into New Zealand from their country, due to either their own country's travel restrictions or the Irish Government's travel restrictions – this includes refusal of travel visa application.

Cancellation of Congress by the Organisers

- Should the Organisers completely cancel the Congress, with no content or sessions being available on-line, registrations will be refunded in full less a \$85 processing fee.
- Under these circumstances the Organisers are not liable for any other expenses incurred, this includes travel and accommodation costs – delegates are encouraged to have sufficient travel insurance in place to cover such other costs.

Postponement of Congress
